DUE TO COVID-19, FAMILIES WERE SHELTERED IN AREA MOTELS INSTEAD OF THE FACILITIES OF FAITH-BASED PARTNERS. THE LENGTH OF STAY WAS EXTENDED TO HELP FAMILIES WHO WERE FURLOUGHED OR LOST JOBS DURING THE PANDEMIC. MEALS WERE PROVIDED BY VOLUNTEERS AND THROUGH A PARTNERSHIP WITH SECOND HARVEST. TWENTY-FOUR FAMILIES EXITED THE SHELTER PROGRAM, 58% TO PERMANENT DESTINATIONS AND 42% TO TEMPORARY DESTINATIONS.
